

Privacy Notice

Handsworth Roadhogs Running Club are committed to protecting and respecting your privacy. For any personal data you provide for the purposes of your membership, the Club Committee is the Data Controller and is responsible for storing and otherwise processing that data in a fair, lawful, secure, and transparent way.

What personal data we hold on you

You may give us information about you by filling in forms at an event or online, or by corresponding with us by phone, e-mail or otherwise. This includes information you provide when you register with the Club or participate in discussion boards such as the Club Facebook page and on the Club website. The information you give us may include your name, date of birth, address, e-mail address, phone number, name of the EA affiliated Clubs with which you are registered, age and gender.

Why we need your personal data

The reason we need your Athletics Data is to be able to administer your membership and provide the membership services you are signing up to when you register with the club. Our lawful basis for processing your personal is that we have a contractual obligation to you as a member to provide the services you are registering for.

Reasons we need to process your data include: -

For training and competition entry

- sharing personal data with club team managers to enter events.
- sharing personal data with facility providers to manage access to the track or check delivery standards; and
- sharing personal data with leagues, county associations (and county schools' associations) and other competition providers for entry in events.

For funding and reporting purposes

- sharing anonymised data with a funding partner as condition of grant funding e.g., Local Authority.
- analysing anonymised data to monitor club trends; and
- sending a Club survey to improve your experience as a Club member.

For membership and club management

- processing of membership forms and payments.
- sharing data with committee members to provide information about Club activities, membership renewals or invitation to social events.
- promoting Club activities through the Club Facebook page; and
- publishing of race and competition results

Marketing and communications (where separate consent is provided)

- sending information about promotions and offers from sponsors through the Club Facebook page.
- sending information about selling club kit, merchandise or fundraising through the Club Facebook page.

On occasion we may collect personal data from non-members (e.g. such as any non-member participant who enters a race organised by the Club). Our lawful basis for processing data is consent. Therefore, we will also need explicit consent from non-members to process this data, which we will ask for at the point of collecting it. It will only be used to contact race participants about races organised by the Club in the future and for no other purpose.

The Club has several social media pages. All members are free to join these pages. If you join these social media pages, please note that provider of the social media platforms has their own privacy policies and that the Club do not accept any responsibility or liability for these policies. These policies can be checked before you submit any personal data on the appropriate Club social media pages.

Who we share your personal data with

When you become a member of the Club you can also choose to be registered as a member of England Athletics Limited. If you would like to register as a member of England Athletics Limited, please indicate on the Membership form, and we will provide England Athletics Limited with your Athletics Data which they will use to enable access to the MyAthletics online portal. England Athletics Limited will contact you to invite you to sign into and update your MyAthletics portal. You can set and amend your privacy settings from the MyAthletics portal. If you have any questions about the continuing privacy of your personal data when it is shared with England Athletics Limited, please contact dataprotection@englandathletics.org. If you do not wish to register as a Member of England Athletics Limited, then we will not share your data with them.

The Club does not supply any personal data it holds for this purpose to any other third party except the South Yorkshire Amateur Athletics Association and other local running clubs for the purposes of entering Club Members in races organised by those bodies. The Club's data processing may require your personal data to be transferred outside of the UK for the purposes of cloud and website hosting etc. Where the Club does transfer your personal data overseas it is with the appropriate safeguards in place to ensure the security of that personal data.

How long we hold your personal data.

We will hold your personal data on file for as long as you are a member with us. Athlete data is updated as required. Any personal data we hold on you will be securely destroyed after two years of inactivity on that member's account. (The England Athletics Limited's retention policy states their period is four years). Your data is not processed for any further purposes other than those detailed in this policy.

Your rights regarding your personal data

As a data subject you may have the right at any time to request access to, rectification or erasure of your personal data; to restrict or object to certain kinds of processing of your personal data, including direct marketing; to the portability of your personal data and to complain to the UK's data protection supervisory authority, the Information Commissioner's Office about the processing of your personal data.

As a data subject you are not obliged to share your personal data with the Club. If you choose not to share your personal data with us, we may not be able to register or administer your membership.
